## **Burtch Land Being Held In-Trust for Six Nations**

As of the end of March 2017, the Province of Ontario has transferred the title of approximately 381 acres known as the "Burtch Land" to a federal corporation directed by Six Nations Elected Council.

The corporation will hold the land, that formerly housed the Burtch Correctional Institute, for the people of Six Nations. All acreage will remain in-trust until it can officially be added to Six Nations of the Grand River Territory in accordance with the

Federal Government's Additions to Reserve Policy.

All costs associated with the transfer of the land have been incurred by the Province of Ontario. The Province has also agreed to incur all taxes on the property until it has been deemed "reserve land," at which time the land will become tax exempt.

For the immediate future, the land will be used for agricultural purposes.

## **Hydro One Rates**

Ontario's Fair Hydro Plan was announced in March 2017, with implementation expected by the summer of 2017. The new plan includes:

- · First Nations On-Reserve Delivery Credit
- An average of 25% reduction of the overall bill
- Enhanced relief through the Rural or Remote Electricity Rate Protection
- · Access to the New Affordability Fund
- Enhancement of the Ontario Electricity Support Program (OESP)

## Telephone and Door-to-Door Scams

A word of caution and warning goes out to all community members, especially our Elders, about telephone and door-to-door scams. Be wary. Ask questions.

If you get a suspicious telephone call ask for their name, phone number and any additional information. You are NOT required to give them any info and can advise them you will be reporting them to the Six Nations Police and Six Nations Elected Council.

Door-to-door solicitors can be asked to display a letter granting permission to solicit from the Elected Council. If they cannot produce one you may call the Six Nations Police to have them escorted off of the Territory.

- Bring an up-to-date status card to Central Administration (1695 Chiefswood Road, Ohsweken)
- Complete a Status Card Form (also available online at www.sixnations.ca)
- Fax in your completed form (faxing is available at Central Administration for a minimal fee)

It takes approximately 2-3 weeks for cards to be delivered. If you do not receive your new card within 6 weeks follow up with us at Central Administration.

### Tax Exemption Letters for Services Delivered to Reserve

If you are being charged tax for services delivered on-reserve i.e. hydro, cell phones, internet, satellite or product deliveries you can have them removed. You will need to provide a copy of your status card, blue number, account number and letter from Six Nations Elected Council.

## **ELECTED COUNCIL UPDATES**

### **Blue Bins**

Six Nations Public Works now has larger blue bins available for better recycling capacity. Bins are available FREE of charge with up to 4 bins per household.

A.W. First Nations Recycling has reported recycling rates within our community are on the rise, with a 40% increase over the 2015 to 2016 year. Please keep helping to protect Mother Earth, and recycle!

### **Bridge Rehabilitation**

This summer we will begin rehabilitating Bridge No. 7 located between Third and Fourth Line. These repairs will impact the flow of traffic through this area, but are needed to ensure the continued safety of our community.

A funding request for the rehabilitation of Bridge No. 15 located on Onondaga Road between Second and Third Line has been submitted.

Overall we have identified 11 bridges in need of rehabilitation in the upcoming years.

### **Construction Debris**

Council has passed a policy to charge \$20 for each Construction Debris Approval issued for the disposal of roofing materials, shingles and other construction debris material(s) at Six Nations Landfill Site.

If you need to dispose of a load of garbage containing construction debris visit Six Nations Public Works (1953 Fourth Line, Ohsweken) Monday through Friday between 8:30am-4pm to complete a Construction Debris Approval Form and pay the disposal fee. Approvals are valid for 72 hours.

### **Funding**

We are advocating Indigenous and Northern Affairs Canada (INAC) for the funding needed to replace two pumper tankers that are more than 25 years old, for the Fire and Emergency Services Department.

We were also successful in securing funding for our Justice Department, to hire two Restorative Justice Workers and two By-Law Officers.

### **Household Hazardous Waste**

The next household hazardous waste event is scheduled for June 2017. For tips on storing waste until this date or for alternative locations for proper waste disposal visit Public Works – Landfill Site at www.sixnations.ca.

### **Landfill Site Hours**

Six Nations Landfill is now operating on summer hours from 8am-5:30pm Tuesday through Saturday. Gates will close at 5:15pm.

### **Ohsweken Infrastructure**

The traffic lights at the main intersection in Ohsweken have been activated and are now functioning. Once Six Nations Public Works has painted the left-hand turning lane, the advanced turning signal will be activated for Chiefswood Road only. Please be aware of pedestrians crossing.

### **Social Services**

Six Nations Social Services will be hosting discussion on child care and early years programs and services. We encourage you to participate, and share your thoughts and ideas on child care accessibility, affordability, expansion, before and after school care, urban child care spaces, and Gahwajiya:de Detenatgwa'ta Family Gatherings (formerly the Resource Drop-In Program). This project is part of the Ontario Ministry of Education's Journey Together initiative, in response to the Calls for Action in the final Truth and Reconciliation Commission Report.

### **Tires**

For tire disposals please inform the Site Guard of the type of tire and source. There is no charge for tire disposal, however this information is reported monthly to the Ontario Tire Stewardship and impacts funding.

### **Waste Management**

We have been able to secure approximately \$3M in funding from Indigenous and Northern Affairs Canada (INAC) to close the existing Landfill Site and build a transfer station in the 2017/18 fiscal year. We are currently in the process of hiring a consultant to design the transfer station plans. Further details will be provided as we move forward.



## District Four Update from Councillor Helen Miller

First of all, I offer my condolences to all the families who have lost loved ones. So much has happened our community is in a constant state of grieving. Our police & emergency services are being stretched beyond limits.

This update is to let you know what is happening in District Four. Or what I would like to see happen. This Council term I chose to sit on: Building & Infrastructure which deals with Public Works & Housing; Education (District #1 Councillor Audrey Powless Bomberry is the chair this term); Environment is a new committee; and a Finance Committee is being contemplated. The External Committees are: GREAT; Mohawk Chapel & Library.

This term as well I plan to travel as little as possible so I can spend more time dealing with local issues. Already I've received numerous calls from people wanting assistance with all sorts of issues from problems with housing to business registration to ditches overflowing.

The Council needs to publicize and start a comprehensive education campaign on our community bylaws. Six Nations has about 100 bylaws on record. Currently, the bylaws are being reviewed but with Council having a one-person policy unit the review process is slow. So Council needs to hire more people in its policy unit. Council is looking to hire a Bylaw Enforcement Officer. But I'm hoping people they will respect the bylaws.

I'm really grateful to GRE for building a new fire hall but at the same time people complain about numerous environmental issues. People complain about the strong smell of cigarettes in the air every so often. It's a health hazard for families in the surrounding areas. The smell is so strong some days it burns the throat. People complain about the smell of sewer coming from GRE, more so in summer. Lately, people tell me the ground around GRE and beyond is water logged. Council needs to develop its own environmental standards, regulations and guidelines. Or partner with Ontario's Ministry of Environment although Council has always maintained provincial environment laws don't apply on reserve. But if we don't have our own laws or standards what else is there. We need to start protecting our environment

I get a lot of complaints about the noise from race nights at Ohsweken Speedway. The Council of the day shouldn't have allowed the speedway in a residential area. Glen Styres did go to council with his plans. He also went to the neighbors who had no objections. The problem is Six Nations does not have zoning and zoning laws.

Cigarette factories, recycling factories and other factories

are being built in residential neighborhoods. Council does not require an extensive environmental assessment on any new development. Nor does Council have any say about on-reserve development. Without zoning laws people can build businesses wherever they choose. Neighbors have no say in what goes next door to them. I remember about 30 years ago when Council mentioned zoning people went ballistic. Now look what is happening to our community.

Stray dogs are a major problem. People have been bitten or attacked by stray dogs. Packs of dogs roam the reserve. We really need to expand our Animal Control Program and hire more staff. This program needs its own building with lots of kennels. Six Nations could even issue its own dog license or those chips.

For the past five years my neighborhood has had issue with loose horses. The farmers complain about the horses eating and trampling crops. My neighbors complain about damage to yards and clumps of poop everywhere. Some people have had near accidents from the horses running unto the road. Right now the horses must be fenced in because we haven't seen them for a while. Sometimes the horses are corralled and sometimes they're not. The thing is when the horses are loose people have nowhere to complain so they call me. The police can only talk to the owner. It's my understanding the SPCA won't come to Six Nations unless asked by Council. Maybe Council should consider establishing a partnership with the Brant County SPCA or maybe we should look at developing our own Six Nations SPCA.

The residents on the unpaved portion of Sixth Line have had to drive over a potholed, washboard road for years. PW scraps the road more often but that's only a band aid. Every time I raise the issue I'm told the road has to be widened, ditched and those over 100 year old trees near the Moses' former estate have to be cut down. As well some houses are pretty close to the road. Brant County chipped and tarred Pauline Johnson Road just the way it was so why can't Six Nations do the same thing? Seneca Road and the end of Fifth Line need to be paved as well.

Then I get complaints about those blue dumpsters in the village. People say the dumpsters are not only an eyesore but a haven for rodents and snakes. The Council has no bylaws regarding the blue dumpsters. So that's something that needs to happen.

Rest assured I'll push these issues every chance I get. Councillor Wray Maracle and I will be hosting one community meeting a month hopefully starting in April so I will keep you posted.


