APPLICATION FOR CITIZENSHIP ON SIX NATIONS OF THE GRAND RIVER

Each applicant must agree and abide with the following.

- Each request will be considered individually basis by the relevant Council Committee, upon favorable review will then be recommended to Council for approval.
- Each applicant must be a citizen of a recognized Iroquoian Nation and must provide proof that they have at least 50% native blood.
- Each applicant must provide documentation of Iroquoian ties to the Six Nations of the Grand River.
- The person must be of good standing or character and a potential benefit to the community. Must supply the following:
 - Three (3) character references from Six Nations
 - Three (3) references from the originating First Nation.
- The person must be economically able to support self and family and not be a burden on the Community's social agency.
- The applicant's signature is a declaration stating that the information in his/her application is true and correct and consent to release their personal information, along with supporting documentation to authorize the Six Nations Council to verify its correctness.
- Should any information in the application be found incorrect, then the application will not be considered.
- Each adult (over the age of 18 years) must make his or her own application.
- Each applicant must sign an acknowledgement to abide by the Six Nations Laws, By-laws and policies.

CPIC and Community Hours:

- Each child age thirteen (13) years and older must at their parent's expense supply a current CPIC dated within thirty (30) days of their application date.
- Each Adult applicant at their own expense must supply a current CPIC dated within thirty (30) days of their application date.
 - Upon completion of the two (2) year probation and prior to an accepting Six Nations Council Resolution being signed, a new CPIC must be completed at the expense of the applicant.
- Each applicant must complete a community service as follows:
 - Adult must complete 20 hours of service
 - Minor over the age of 13 must complete 20 hours of service
 - Minor age 12 and under must complete 5 hours of service

Minor Children:

- In the case of a minor's application; the parent or legal guardian must sign a declaration stating that the information in his/her application is true and correct; consent to release of their personal information, along with supporting documentation to authorize the Six Nations Council to verify its correctness.
- Both parents of the minor child under the age of Eighteen (18) years must sign the consent to transfer the child.
- Consideration will be given to a Nation to Nation transfer of a minor child with only one parent's signature, if that parent has a legal custody order signed by a Judge. A copy of the court order must accompany the application.

- Adopted children from a Non-Iroquoian First Nation may be transferred to the Band of their adoptive parents; once the children reaches the age of Eighteen (18) years that child may decide which Band they wish to be registered with, either their original Band or remain on Six Nations of the Grand River.
- Minor children must complete all the applicable rules and regulations under Section 3

Probationary Period:

A person whose application for membership has been accepted for consideration by the Six Nations Lands Membership Committee must fulfill a probationary period of (2) years before full membership is acquired.

A person who violates the peace and security of the Six Nations of the Grand River during the probation period will forfeit his/her probation and his/her application for membership will be cancelled.

After successful completion of the two (2) year period, the relevant Council Committee will recommend to Council to sign a Six Nation Council Resolution requesting Indian and Northern Affairs Canada to amend their records to show the name of the applicant under the Six Nations of the Grand River Membership List.
